



BIKE RENTAL POLICY

Eligibility

Baltimore Bicycle Works reserves the right to refuse renting equipment to those with insufficient knowledge or ability for their own protection and safety. Those renting bicycles must be over 18 years of age or be accompanied by guardian.

Reservations

A deposit for one day of rental is required to reserve your equipment. Payment may be made with cash or credit card. Reservation fees on equipment will begin the intended day of rental. Balance must be paid in full before picking up the equipment, with fees added if equipment is not returned in the condition in which it was rented. Baltimore Bicycle Works reserves the sole right to determine the condition returned.

Security Deposit

A credit card is required for an equipment deposit. The renter will be charged for repairs or replacement of damaged or lost equipment, and assessed a cleaning fee for returning dirty equipment. Please treat our equipment as if it were your own or better. We take pride in our gear and hope you will enjoy and appreciate the value and performance of our top of the line equipment.

Equipment Rental Rates

Bicycles: \$50 - 24 hour day \$200 - 7 day week
E-Bicycles: \$75 - 24 hour day \$400 - 7 day week
Burley child trailer: \$30 - 24 hour day \$120 - 7 day week
Accessories: \$5 per item for the entire rental period

Daily rates are based on a 24-hour period. No refunds will be made due to weather conditions, equipment returned early, or for equipment rented but not used. *Equipment returned late will be charged \$10.00, plus the additional day rate for each day it is late.*

Cancellation Policy

Reservations may be cancelled up to 48 hours in advance of rental period for a 50% refund of the deposit. Any no-shows or cancellations less than 48 hours in advance will forfeit the entire deposit.

Rental Agreement Terms

- I assume full responsibility for all of the equipment provided to me by Baltimore Bicycle Works and hosting facility and will treat it carefully as if it were my own.
- I will return it in the same condition that it was provided to me. This includes washing all equipment completely.
- I understand that I will be billed for any damage incurred to the equipment.
- I understand that I am responsible for the security of the equipment and will be billed in the case of loss or theft. Retail price replacement cost will be charged to my credit card if items are not returned.

- I will wear my helmet at all times while biking.
- I will practice appropriate rules of the road, understanding that other vehicles have the right of way. I will ride with the traffic and follow traffic rules.
- I attest that I will be aware of the weather and road conditions.
- If bicycle is transported I will be responsible for carrying it in an appropriate manner approved by Baltimore Bicycle Works.
- *I acknowledge that I have voluntarily rented and in consideration of being permitted to rent, I voluntarily execute this "Release and Assumption of Risk" on behalf of myself, my heirs, next of kin, my personal representatives and my estate.*
- *I accept and assume full responsibility for all harm and injury, of every nature, including death, which may occur to me and I assume full responsibility for damages or loss of personal property or property issued to me by Baltimore Bicycle Works and hosting facility while I'm participating in program or using their property. I agree to indemnify and hold harmless Baltimore Bicycle Works and its employees and its hosting facility, from and against any claims, demands, actions or causes of action, on account of damage to personal property, or to my personal injury or death, which may result directly or indirectly from my participation and which results from causes beyond the control of and without the fault or negligence of Baltimore Bicycle Works and its employees.*
- *I request that this "Release and Assumption of Risk" be construed and interpreted pursuant to the laws of the State of Maryland and if any portion is held invalid, the remainder will continue in full force.*
